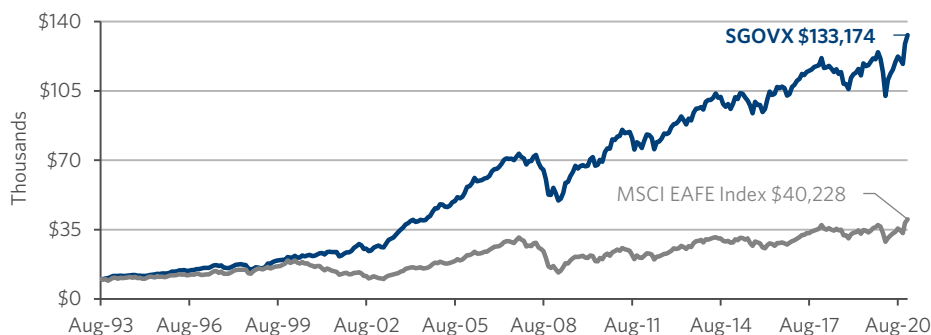
Seeks long-term growth of capital by investing primarily in equities issued by non-U.S. corporations.

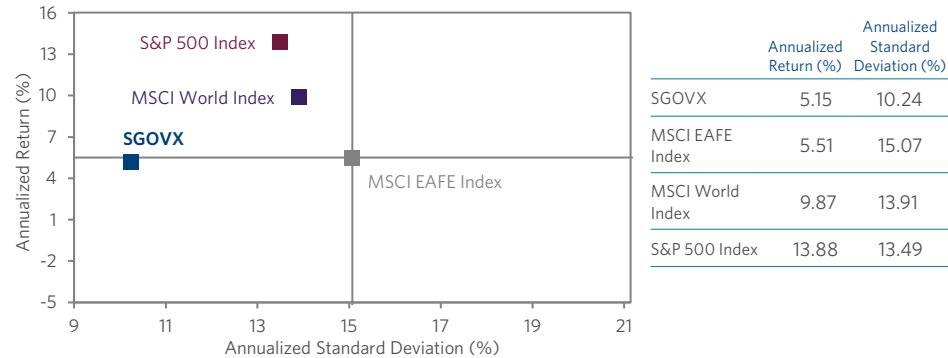

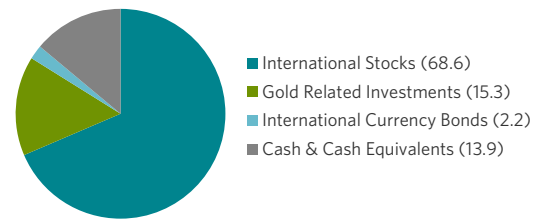

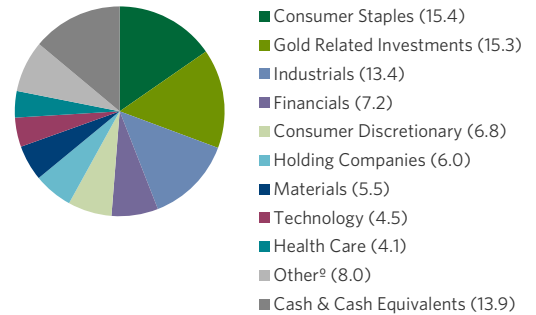

Allocation By Asset Class (%)⁶

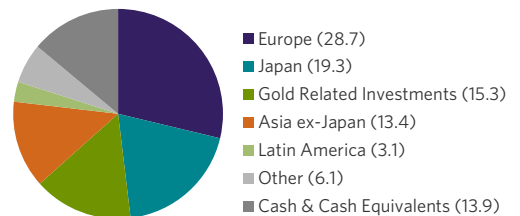


Allocation By Sector (%)⁶
